Trending and Benchmarking

Trending and benchmarking reports are valuable tools for any organization. When viewed within the context of similar organizations, we can more easily see what our strengths are and where our greatest potential remains. By viewing trends over time in this same context, we can see where we're in line — or not — with others in the industry. We must also keep in mind that even amongst organizations of similar size or resources, there may be environmental factors that aren't expressed in numbers but still play a part in the performance of the organization. The metrics tell the first part of the story, but if the goal is to move the needle on the numbers, we must then look deeper into what factors are influencing that area.

Data in This Report

All data in this report comes from the Institute of Museum and Library Services (IMLS) Public Libraries Survey. Single-year data is for Fiscal Year 2017, which is the most current year publicly available as of August 2019. Trend data reflects Fiscal Years 2013 - 2017.

National Peer Group Determination

Baltimore County Public Library's national peer libraries have been identified using IMLS data from FY 2016-2017, the most recent year publicly available in August 2019. Peers are determined as those that fall within a similar range of the following three operating conditions:

- 1. Service area population (+/- 35%)
- 2. Total operating expenditures (+/- 35%)
- 3. Number of branches, including central and branch libraries (+/- 20%)

Within the peer group, Baltimore County falls in the mid-range for service area population, near the top for total operating expenditures, and near the low end for number of branches.


Of Note

The most comparable systems to Baltimore County, using these criteria, are Indianapolis-Marion County Public Library, Sno-Isle Libraries and Saint Louis County Library.

One peer system, Saint Louis County, shares with Baltimore County the geographical quality of serving an urban/suburban county directly adjacent to but not including a major U.S. city. Salt Lake County was removed from the peer group in FY17 due to a budget increase above the calculated range.

Maryland Libraries

Maryland's 24 public library systems represent each of the 23 counties and Baltimore City. All Maryland libraries share a robust reciprocal borrowing agreement and strong collaborative efforts on statewide policy and funding initiatives. However, reflective of the state's diverse geography and demographics, there is a wide range in library system size and resources.

Maryland Libraries Peer Group

Throughout the detail sections of this report, trend charts are shown for several measures. These charts show Baltimore County's change over time in particular areas, within the context of its peers. In order to facilitate readability, Maryland libraries have been limited to a radius of two counties in any direction around Baltimore County. This peer group includes Anne Arundel, Carroll, Cecil, Frederick, Harford, Howard, Montgomery and Prince George's counties, as well as Enoch Pratt Free Library in Baltimore City.

Of note, two Maryland systems, Enoch Pratt and Montgomery County, are also included in Baltimore County's national peer group.






Programs per 1,000 People




Total Program Attendance




Program Attendance per 1,000 People



Programs per 1,000 People: Trend




Program Attnd. per 1,000 People: Trend


Total Library Visits




Library Visits per Capita



Total Library Visits: Trend




Library Visits per Capita: Trend




Circulation per Capita










Total PC Sessions




PC Sessions per Capita








Program Attendance per 1,000 People



Programs per 1,000 People: Trend




Program Attnd. per 1,000 People: Trend









Visits per Capita




Circulation per Capita






PC Sessions per Capita
