Baltimore County Public Library is governed by a seven-member administrative board appointed by the County Executive for a five-year term with the possibility of reappointment for an additional five years. The board operates under Laws of Maryland Related to Public Libraries.

Responsibility

The Board of Library Trustees has the legal authority and responsibility to oversee the library system is well managed.

Areas of responsibility include:

- Hires and evaluates the library CEO, who manages the day-to-day operations of the library system.
- Establishes library policy working with the CEO and staff to ensure the library system is sound and responds to the needs of the public. Major policy areas include personnel, collection development, public service planning, technology and budgeting.
- Stays current on current library trends through reading headlines. attending professional meetings and visiting other libraries.
- Serves as an advocate to convey the value of the public library while sharing the mission, identifying funding resources and garnering support of elected officials, community members and business leaders.

The Board currently meets in the morning on the third Tuesday of the month.

Qualifications:

As a candidate for a library trustee position, you must be a resident of Baltimore County and representative of the constituent base the library serves. You must also have:

- Demonstrated interest in the library.
- Readiness to devote time and effort to attend board meetings. serve on committees, advocate for the library and participate in other trustee activities.
- Ability to plan creatively and carry out plans effectively.
- Ability to analyze efficiency of business procedures and to be a part of the accountability in the process.
- Ability to communicate effectively verbally and in writing.
- Ability to work well as a member of the team.

How to Apply and Selection Process

Vacancies are available periodically and filled from the pool of candidates who have completed applications. Please see the included application or online at bcpl.info.

When a position is available, all applications are reviewed by the current Board of Trustees. Interviews are granted to candidates based upon level of experience and diversity, including but not limited to diversity of race, gender, professional background and geographic residency to ensure our board provides an accurate cross-representation of Baltimore County. Upon completion of the interviews, the name(s) of those most qualified are sent to the County Executive, who makes the final appointment. Upon appointment, the candidate is required to file a financial statement with the Baltimore County Ethics Commission.
